### TYPICAL FEATURES AND APPLICATIONS

3-Ureidopropyltrimethoxysilane is a ureido-functional organosilane. Its structure features a reactive ureido group and hydrolyzable methoxy groups attached to a silicon atom. This bifunctional nature allows it to bond organic polymers to inorganic surfaces, making it a versatile coupling agent and adhesion promoter. It hydrolyzes in moisture to form silanol groups, which can bond to hydroxylated substrates such as glass, ceramics, and metals. It has better stability than aminosilanes in reactive polymer systems, like phenolic, epoxy, urea-melamine or polyurethane.

Ureido-functional silane does not generate color with time and aging. Ureido-functional silane provides nitrogen reactivity without typical aminosilanes strong basic characteristics.

### INFORMATION FOR USE

Ureido-functional silane has good adhesive and sealant adhesion to oil metals.

SC-2510 can improve adhesion between the inorganic filler or fiber and the polymer.

SC-2510 can be used for glass fiber sizes and finishes, wool insulation resin binders, numerous primers, foundry sand binders, adhesives, sealants and abrasive grinding wheel binders.
